

# The Government Plenipotentiary for Disabled People

The Government Plenipotentiary for Disabled People supervises execution of tasks specified by the Act of 27 August 1997 on vocational and social rehabilitation and employment of persons with disabilities.

Being the Secretary of State in the office servicing the minister competent for social security, the Plenipotentiary shall be appointed and dismissed by the Prime Minister, on request of the Minister of Family and Social Policy.

The tasks of the Plenipotentiary include among others:

1. initiating, supervision and coordination of execution of tasks resulting from the law,
2. initiating control of implementation of tasks resulting from the law,
3. demanding from relevant entities information, documents and periodic reports on implementation of tasks laid down in the law,
4. organization of conferences and trainings,
5. providing information on issues concerning vocational and social rehabilitation and employment of persons with disabilities,
6. developing standards in the field of implementation of tasks laid down in the law,
7. drafting and giving counsel on legal acts on employment, rehabilitation and living conditions of persons with disabilities,
8. drafting governmental programmes aimed at the solution of problems of persons with disabilities,
9. formulating the underlying principles of annual material and financial plans concerning the implementation of tasks resulting from the law,
10. undertaking activities aimed at limiting effects of disability and barriers which make it difficult for persons with disabilities to function in society,
11. co-operation with non-governmental organizations and foundations for persons with disabilities.

The Plenipotentiary performs his tasks with the aid of the Office of the Plenipotentiary, which forms a separate organizational unit in the Ministry of Family, Labour and Social Policy.

Since November 2020 the post of the Government Plenipotentiary for Disabled People has been occupied by Mr. Paweł Wdówik.

The Government Plenipotentiary for Disabled People opens his office for the Open Day, each second Tuesday of the month, from 2 p.m. to 4 p.m.
